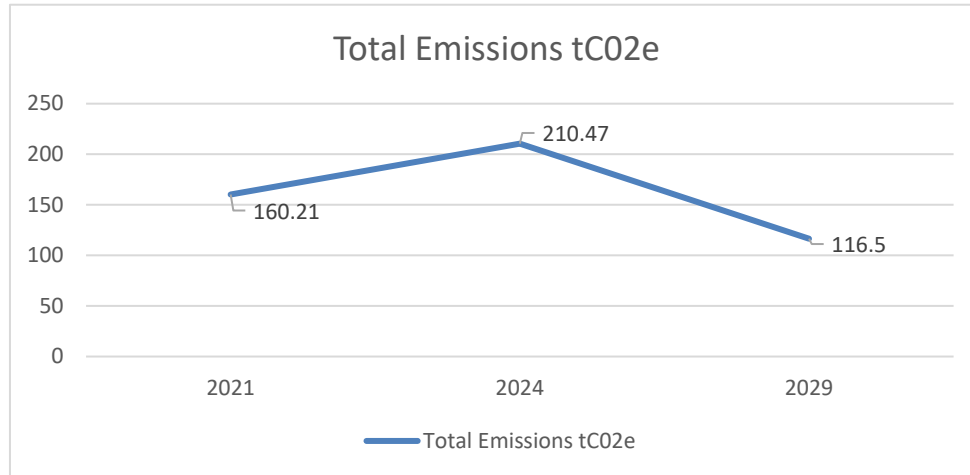

Emissions reduction targets

In order to continue our progress to achieving net zero, we have adopted the following carbon reduction initiatives.

We project that carbon emissions will decrease over the next five years to 116.5 tCO₂e by 2029. This is a reduction of 45%.



Carbon reduction projects

Completed carbon reduction initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equates to 93.5 tCO₂e, a 58% reduction against the 2021 baseline and the measures will be in effect when performing the contract.

In 2024 we implemented an employee electric car scheme. As of 31/12/24 7No. employees migrated over to this scheme changing from petrol/diesel vehicles to fully electric vehicles saving 7.1 tonnes.

Future carbon reduction initiatives

In the future we hope to implement further measures including:

- PV installation at our Plymouth office saving 2.3 tonnes per year
- Replacement of 50% of van fleet from diesel to electric vans by 2029 saving 81 tonnes per year.
- A further 10 electric cars being introduced through our employee scheme saving 10.2 tonnes per year.

Declaration and sign off

This Carbon Reduction Plan has been completed in accordance with PPN 006 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹³ and uses the appropriate government emission conversion factors for greenhouse gas company reporting.¹⁴

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements (where required), and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard.¹⁵
